ENERGY CODES (Michael R.)- Quarterly 2nd Tuesday every 3 months 1PM

- The determination from DOE on the 2024 IECC was released (<u>found here</u>), and anticipates estimates national savings of approximately:
 - o 7.8 percent *site* energy savings
 - o 6.8 percent *source* energy savings
 - 6.6 percent *energy cost* savings
- The committee rosters for the 2027 IECC development process have been selected and can be <u>found</u> here;
- Massachusetts Stretch Code Updates (<u>found here</u>) are anticipated in February.
- Michael is working with Andy on an Embodied Carbon code compliance sheet for DOER. Ideally to put in a technical guidance document. How to show compliance with the embodied carbon provisions.
