***** Training Committee (*Joe Rando*)

- ➢ Winter 2020 Training
 - Online: Jan 6-31/ Classroom: Feb 10-14 (Springfield, MA)
 - We have 11 full registrations, 1 classroom only, 1 cancellation.
- Spring 2020 Training
 - Online: March 30-April 4/ Classroom: May 4-8 (Manchester, NH)
 - Posted on website, publicity going out soon.
 - Looking for better continuity going from online to classroom sessions. Working with Trainers to make the continuity better.
- ▶ RFP Fall 2020
 - Looking at doing 2 year contract, but instead of 6 trainings it would be potentially 3 trainings each per trainer
 - Each trainer would have their own online materials for the training
 - Talked about the need for a 2 year contract on the training call;
- Start Smart Recordings
 - We helped Abode Energy Management get RESNET credits for their fall 2019 conference. They recorded the presentations and we now are working on whether the recordings will be on our website or theirs. It's a lot of CEUS.

Manual Committee (*Mike Browne*)

- Committee has made updates to keep up with the 2019 ANSI Standard.
 - 1.3 Rating Standards [This Section needs to be updated to correctly refer to the current MINHERS Standards and ANSI Standards 380 and 301. Furthermore it should discuss transitions and when it is appropriate to use each version of the standard.]
 - 4.8.a Blower Door Testing [This section needs to be updated to include practices from the most recent RESNET/ANSI 301-2019 and 380-2019]
 - 5.1 Multi-Family Overview and 5.3.a Multi-Family Performance testing guidelines. [These should be updated to include references to the most recent RESNET/ANSI 301-2019 and 380-2019 and also the new ENERGY STAR Multi-Family Program.]

***** Technical Support Forum- Jonathan Martin

- The software for our website has a built-in forum feature. It will work perfectly for what you need. All your members already have logins, they will use the same login for the forum.
- www.nehers.org/forum
- If you click on QA Support Forum in the table, this is where you would add a question. Hit new thread and it gives a box for them to put their question. Once it's posted, people can reply to it. Or start a new thread.
- Members can subscribe to a specific thread or for the whole forum so they are notified when something new is posted.
- > Could seed it with questions to show members how to use it.
- Do we need moderators? Moderators would be in charge of forum content and help keep people on topic. They could delete posts that are not helpful or block people. But only members can access the forum, so it shouldn't be too be of an issue. Moderator would get all subscription emails and have the power to delete posts and edit them. We can try to find someone who wants to volunteer to take on that role. If the volume is low, it's not that big of a commitment.
- Frank prefers Rater Support Forum instead of QA Support Forum, we don't want to give the impression that all of the responses are coming from a QAD. Mike suggested Rater Discussion Forum.
- Is there a way to show the member's credentials, like Rater or QA with their posts? It's capable of doing that but right now we just know them as their member type. We could have people give a blurb about who they are.



- How does it pick which category they are? Some people are in the database in multiple categories. Their website login is slightly independent. It's tied together so if they change their name it will change it on their login name also. But it's not so tight that they are tied to a specific member type. So you might want a box to put what their role is. That's a quick change. Can identify multiple roles if they have them.
- ▶ How do we get to the forum- where will it be? In the member's corner?
- > We will send an email to let members know it is there.
- Do we want it to be publicly viewable but only members can post? Yes, that's how it's currently set up. Shouldn't be in member's corner. We can have it linked from the public side but then in the member's corner have a link to post to the forum.
- Should we put it on the main menu? The main menu is pretty full. Maybe we could combine something. Or put it at the top by members corner
